


ONE TEAM

You are part of our team too, and your support has made a positive difference in the lives of our children and their families. Thank you for bringing our mission to life again this year.



As the stay-at-home order went into effect in March, La Rabida assembled a specialized team to make sure patients who needed care could connect with our medical teams through telehealth. Thanks to the hard work of that team, more than 80 percent of in-person appointments were successfully transitioned to telehealth visits within the first two weeks of the shutdown.
