Caring for Children with Disabilities

Mom Ana found out she was having a little girl with Down syndrome when she was five months pregnant. She wasn't sure what her daughter's life would be like, but she was determined to make sure it was a full one.

Navigating the journey can be overwhelming, but with the right team on their side Jennifer and her family have received the support they need at La Rabida.

From speech therapy, occupational therapy and physical therapy, Jennifer works hard every week to become more independent. With the help of her team of therapists, Jennifer has made tremendous progress.

"I have seen a lot of improvements in Jennifer since being at La Rabida," explains mom Ana. "Jennifer's speech has really improved and she is able to communicate better."

Physical therapy has also helped her with activities like jumping and going up the stairs. She has also learned to write and get dressed on her own thanks to occupational therapy.

Oral Motor Feeding Clinic

Asia was born premature with a cleft palate and an undersized jaw. After five months in a neonatal intensive care unit (NICU), multiple surgeries, and several weeks of rehabilitation aboard the S.S. La Rabida, Asia finally went home to her family. But her condition and the surgeries to repair her face and mouth affected her ability to eat, and her nutrition suffered.

"It got to the point that Asia wouldn't take a single bite. She would see food and start crying," her mom Adilene remembers. "Sometimes I would pause the tube feeds and be like, okay, I see you're hungry. You're going to have to eat food because I know that you're capable of doing it."

That's when they turned to the team at La Rabida's Oral Motor Feeding Clinic for support. The team of dietitians, speech therapists and social workers help families find appropriate eating methods and reduce stress at mealtimes for the entire family.

Diabetes Clinic

Andrea, mom to Josefina, had an inkling something was wrong when her daughter was always thirsty and frequently urinating. One morning her head began slumping over while she was eating breakfast.

"Our world changed within 20 minutes," her mom says. "She was diagnosed with Type 1 diabetes that day. You don't ever forget that day."

The La Rabida team, from that very first day, helped pick us up as a family and walked us through each step. Each day we focused on different things. We met with the nurses, the diabetes nurse educators, the endocrinologists, the social worker, the dietitian – you name it there was a person for it."

The goal of La Rabida's Chicago Children's Diabetes Center (CCDC) is to help support kids like Josefina navigate the obstacles they are facing while also providing support for their families.

Sickle Cell Clinic

La Rabida has one of the largest pediatric sickle cell programs in Illinois.

Malik, 16, and Syncere, 12, were each diagnosed with sickle cell mere days after they were born.

"I was terrified. I didn't know what this meant for my baby. I didn't know what sickle cell was," says their mom Sharletta. "I've learned everything about sickle cell from La Rabida. I've learned a lot about pain, how to help the boys, and signs to look out for. The care team has also taught them how to manage their pain themselves."

Healing After an Accident

In 2021, two-year-old Pierre was involved in a car accident that left him unable to walk or talk. Doctors found bleeding on one side of his brain and a fracture on the other, bringing his development to a screeching halt.

"Before the accident, Pierre was like any normal two-year-old. He was running around, talking, and just being a kid," says his mom, Jalessa. "After the accident, he lost a lot of that."

Once Pierre was stabilized and received immediate care at a major medical center, he was transferred to La Rabida for inpatient rehabilitation. Here, he worked closely with physical therapists, occupational therapists, speech therapists, infant development and child life specialists. This holistic team worked one-on-one with Pierre and his family to help him regain the skills he lost during the accident.

He began to talk again with therapy and he started to walk again. He also used the La Rabida therapy pool to build up his strength and endurance.
